

“Torah Refutations of the Great Reset”

Introduction.

The Midrash tells us this:

"Chazal teach us that "God looked into the Torah and created the world" (Yalkut Shimoni, Mishlei 942). The Torah is the blueprint of all creation. In order to understand the world in which we live, and the purpose of our own lives, we must study Torah."

I have come to understand that point as follows: the wisdom of the Torah can be applied to all times and places. Indeed, Rabbi Jonathan Sacks (of blessed memory) - among many other Jewish scholars - spent much of his professional life showing how Torah values, ideas, and principles can be applied to solve the problems of today's world.

I have been especially eager to discover Torah guidance in dealing with what I consider to be the biggest problem we currently have: the attempted Great Reset by Global Marxists.

Qualifiers.

Before I continue, let me say this:

I am a political person. I was raised by political parents. I was taught to stand up for myself - especially against authority.

I understand that politics - the exercise of governmental power - affect everything. I also am willing to challenge those politics when they are persecuting me and mine.

This is especially true with the so-called "pandemic."

Now, I understand that many people are sensitive about Covid, and "vaccines," and "conspiracies." They would rather go along, to get along. That is your right, and you are entitled to your opinion.

But in my opinion, the only way to get through it, is to go through it. That means we deal with the fact that we and our freedoms are being attacked 24/7, everywhere in the world - because of politics, and not an actual "health emergency." If you follow the science, and the data, and the evidence, this is what you conclude.

So we need a defense strategy that applies all the time, in all places.

That, my friends, comes from the Torah.

In this D'var Torah, I am going to share some of what I have learned about how the Torah can help us defeat this Global Medical Tyranny. It will include inspiration and insights to deal with some of the elements of the attack.

I am sure no one is really comfortable talking about a war on humanity. I am going to do my best to help us all get a little stronger in the effort to win it.

Having said this, let me continue.

The Big Picture.

This is a summary of the Great Reset / Pandemic in an essay just published by Dr. Robert Malone. He did so to publicize a March on Washington to Defeat Vaccine Mandates, on January 23.

(Dr. Malone: inventor of mRNA vaccines and DNA vaccines; world-wide expert in RNA technologies RW Malone MD, LLC, The Unity Project and The Malone Institute. MD, MS, GCSRT Harvard)

I present it because I have spent two years trying to figure what is behind this Covid Catastrophe. Dr. Malone sums it up nicely. FYI: I have a plethora of material to back this up.

Dr. Malone:

"The underlying truths of the grossly mismanaged globally coordinated response to the COVID-19 outbreak are becoming increasingly apparent to common citizens throughout the world. The United States Health and Human Services (HHS) system, once considered the world standard for medical research and for insuring purity, safety and effectiveness of drugs and vaccines, is now being seen by many as corrupt and compromised. Over the next year, additional data documenting and supporting this corruption will continue to emerge. The growing tide of whistleblowers, truth tellers and their lawyers will swell to the point that it will overwhelm the censorship and propaganda which the guilty and their accomplices are desperately using to try to hide their duplicity."

"Looking forward into this new year that is now upon us, I predict that a broad global consensus will emerge that the integrity of our entire western health care systems, our media, big tech, and western political systems has been breached by the corrupting influence of a financial system that has lost integrity and become decoupled from any sense of morality, and

which perceives no economic value in either fundamental human dignity or community. A financial system which has become completely decoupled from the historic concept of the nation-state. One that defines and thereby degrades human beings as mere economic units to be exploited for rents and profit using a wide range of innovative strategies."

"This globalized financial system exists for one purpose only: to maximize return on investment. And those who control this system see centralized global totalitarianism as a more efficient management structure for extracting value from you and me. To them, the logic of a digital social credit system is compelling, as it will optimize population control and maximize profit. In a sense, we already have a version of this in operation- your credit rating score. Now imagine a world in which not just your access to capital ("credit"), but your every financial transaction is subject to approval, control, and various forms of taxation based on a rating score which is dependent on your behavior, political views and speech."

(If you want to know what that feels like, just ask people living in Communist China.)

"If there has been one constant throughout these last two years, it has been the gross mismanagement and incompetence of government officials tasked with the public health response. How can we trust them to make intelligent, data-based decisions in the future? How can you trust them to decide what is best for your children? No, you have to personally own these decisions now. They will not be there to help if you or your child are damaged by these vaccines. And you will get no legal or financial relief. Both Pfizer and governments have been absolved of all legal accountability. You will have to bear that

burden, financially and psychologically, for the rest of your life and that of your child."

"At this point, the unresolved outstanding issue is whether or not the citizens of the United States and western countries will rise up, resist and overthrow the globalist overlords, coercion and agenda which is being forced on us, and which is continually reinforced by a massive propaganda and censorship campaign the likes of which the world has never seen before. This is modern twenty first century media warfare, and the common man is almost hopelessly outgunned."

I know these words are hard to accept. There are no enemy soldiers in the streets, so it is hard to believe we are at war. The idea that our own government is out to get us is frightening.

In whom do we trust?

As Jews, we know exactly in Whom to trust. So we look into His Torah for guidance and inspiration.

Torah teachings that can be used to refute the Great Reset.

Let's look at some examples, using the commentary of Rabbi Sacks on various Torah portions (his comments are in italics; mine follow.)

Again, the purpose here is to show how the teachings of Rabbi Sacks about Torah values, ideas, and principles, can be applied to the problem of the attempted Great Reset. It is by no means comprehensive, and certainly not a portrayal of how halacha, of

Jewish law, may address the problem.

1. re: The Creation of People (Gen 1.26-27)

"The Genesis of Justice (Bereishit 5775)"

A: The Torah emphasizes morality and ethics in how we live.

Tov is a moral word. The Torah in Genesis 1 is telling us something radical. The reality to which Torah is a guide (the word "Torah" itself means "guide, instruction, law") is moral and ethical. The question Genesis seeks to answer is not "How did the universe come into being?" but "How then shall we live?" This is the Torah's most significant paradigm-shift. The universe God made and we inhabit is not about power or dominance but about tov and ra, good and evil. For the first time, religion was ethicised. God cares about justice, compassion, faithfulness, loving-kindness, the dignity of the individual and the sanctity of life.

Rabbi Sacks is pointing out that from the Torah point of view, good and evil exist in our world. Our religious practice should promote the moral and ethical good. That implies, of course, that you have to call out evil when you see it, in order to avoid it - and put a stop to it.

Many government actions in response to Covid could and should be termed evil. State governors forcing nursing homes to take in people sick with Covid, is evil. Hospitals denying early treatment to sick people, is evil. Doctors giving an experimental

drug - with proven dangerous side effects - to children and others who do not need protection in the first place, is evil.

To make matters worse, these actions are being taken under the pretense of "protecting the public health" - despite the vast and growing evidence to the contrary (i.e. at least 150,000 deaths from the jab in the US alone.)

Rabbi Sacks is reminding us that the Torah calls for the sanctification of life. Policies that result in killing or injuring some people to save others, cannot be justified from that point of view. Tragically, the Jewish people are all too familiar with policies that call for killing off a minority group for the betterment of the majority.

We should be the first people to call out this evil, fake moralism.

B: The Torah is a political protest against social power hierarchy.

This same principle, that Genesis 1 is a polemic, part of an argument with a background, is essential to understanding the idea that God created humanity "in His image, after His likeness." This language would not have been unfamiliar to the first readers of the Torah. It was one they knew well. It was commonplace in the first civilizations, Mesopotamia and ancient Egypt. Certain people were said to be in the image of God. They were the kings of the Mesopotamian city states and the pharaohs of Egypt. Nothing could have been more radical than to say that not just kings and rulers are God's image. We all are. Even today the idea is daring: how much more so in an age of absolute rulers with absolute power.

Understood thus, Genesis 1: 26-27 is not so much a metaphysical statement about the nature of the human person as a political protest against the very basis of hierarchical, class- or caste-based societies whether in ancient or modern times. That is what makes it the most incendiary idea in the Torah. In some fundamental sense we are all equal in dignity and ultimate worth, for we are all in God's image regardless of color, culture or creed.

Rabbi Sacks is emphasizing that the Torah considers all people essentially equal, because we are each created in the image of God. Neither caste, class, economic status, nor any other social hierarchy, determines our worth and dignity.

This flies in the face of the elite globalists who are engineering the Great Reset, and facilitating the "pandemic." You can look at the statements of the World Economic Forum, and see this elitism in all its horror. These people actually promote the notion that in the future, "you will own nothing." Who will own everything, from land to cars to clothes? They will - the "global monarchs."

(If you want to know what that feels like, just ask the people living in Communist Australia.)

As Dr. Malone describes, the ruling elite want to impose a vaccine hierarchy, through which an underclass is continually persecuted. That is how they will control what you have - your business, your assets, your health. Of course, the bitter irony is that today, the underclass is the "unvaccinated;" tomorrow it will be those with nine boosters instead of the required ten.

The Jewish people know all too well the perils of being classified at the bottom of such an intersectionality hierarchy.

We should be the first to protest policies that create elite hierarchies, such as "vaccine" mandates.

2. re: The Tower of Babel (Gen 6.5-7, 11.1-9)

“Individual and Collective Responsibility (Noach 5777)”

A: In a world without the respect of individuality, the less powerful get subjugated.

... we now have important historical evidence as to exactly what was meant by the sentence, “The entire land had one language and a common speech.” This may not refer to primal humanity before the division of languages. In fact in the previous chapter the Torah has already stated, “From these the maritime peoples spread out into their lands in their clans within their nations, each with its own language.”

The reference seems to be to the imperial practice of the neo-Assyrians, of imposing their own language on the peoples they conquered. One inscription of the time records that Ashurbanipal II “made the totality of all peoples speak one speech.” A cylinder inscription of Sargon II says, “Populations of the four quarters of the world with strange tongues and incompatible speech . . . whom I had taken as booty at the command of Ashur my lord by the might of my sceptre, I caused to accept a single voice.” The neo-Assyrians asserted their supremacy by insisting that their language was the only one to be used by the nations and populations they had defeated. On this reading, Babel is a critique of imperialism.

There is even a hint of this in the parallelism of language between the builders of Babel and the Egyptian Pharaoh who

enslaved the Israelites. In Babel they said, "Come, [hava] let us build ourselves a city and a tower . . . lest [pen] we be scattered over the face of the earth" (Gen. 11:4). In Egypt Pharaoh said, "Come, [hava] let us deal wisely with them, lest [pen] they increase so much . . ." (Ex. 1:10). The repeated "Come, let us . . . lest" is too pronounced to be accidental. Babel, like Egypt, represents an empire that subjugates entire populations, riding roughshod over their identities and freedoms.

Here, Rabbi Sacks is showing how the Torah links the suppression of free speech to totalitarianism. Imperialists attempt to silence those who resist.

The "vaccine" tyranny of today is a horribly vivid example of this. Government agencies prevent hospitals and doctors from prescribing preventive measures and early treatment. Practitioners who dissent are fired and blacklisted.

State-run media promotes "vaccines" as the cure for Covid, and mislead the public into believing they are safe and effective. Critics are censored and cancelled.

The "unvaccinated" are blamed for the pandemic, even though the data shows the "vaccinated" keep getting sick. Nonetheless, dictator bureaucrats call for putting the unvaccinated in concentration camps.

(If you think this could not happen in America, just take a look at what the NY state Legislature is considering this year.)

In spite of all this oppression by government agencies and the organizations they control, corporations, local businesses, and communal institutions like schools and houses of worship - including Jewish - fall in lockstep with government decrees, and push their staffs and patrons to conform with government

guidelines. Personal freedom be damned. And so they become partners in government tyranny.

In my opinion, Rabbi Sacks' analysis reminds us that when people "just do their jobs" or "just follow orders" with oppressive government policies, many lives get ruined. People lose their jobs, businesses, health, rights as citizens, and lives. Jews know this all too well.

B. Rabbi Sacks makes one final point regarding the "crushing of individuality," both national and personal:

... we will have to re-read the entire Babel story in a way that makes it much more convincing. The sequence is this: Genesis 10 describes the division of humanity into seventy nations and seventy languages. Genesis 11 tells of how one imperial power conquered smaller nations and imposed its language and culture on them, thus directly contravening God's wish that humans should respect the integrity of each nation and each individual. When at the end of the Babel story God "confuses the language" of the builders, He is not creating a new state of affairs but restoring the old.

Interpreted thus, the story of Babel is a critique of the power of the collective when it crushes individuality...

I personally cannot think of a worse way to rob a person of his individuality, than to reduce him to a number. When a government does this, it is not just assigning a number for reference or accounting; it is doing so for control.

Conclusion.

This is the intent of the people behind the Great Reset. The pandemic serves their purpose of promoting vaccine passes. The passes serve their purpose of controlling society, to accumulate our wealth.

Social critic Todd Butterfield makes this point in a very convincing way. He simply went to the website of the World Health Organization to see what plans they have for these vaccine passes. They, and their sponsors Bill Gates and other globalists, are among the chief advocates and creators of these passes.

Here are highlights from the “guidelines” posed by the WHO, with Todd’s commentary:

If a person complies and gets their COVID-19 shots, they get a personal QR code. They can show this code on their smart phone to participate in society. This plan is being rolled out around the world and has spread from Israel to Europe to Australia, and now has been established in the most strategic U.S. cities including Washington D.C., New York, Boston, Philadelphia, Chicago, San Francisco, and Los Angeles. Some people with a

whole lot of power are now seizing a whole lot more power in the name of public health.

There is an important guidance for COVID-19 vax passports that the World Health Organization published at the end of August 2021. The title of this guidance is Technical Specifications and Implementation Guidance on Digital Documentation of Covid-19 Certificates. This “Guidance” provides direction to countries as they issue digital COVID-19 vax passes, so that all these will meet common standards and potentially function together.

Some of the things in the Guidance are pretty hard to believe -- you have to read them for yourself. For starters, everyone in the world with a vaccine passport receives their own ID number. This is called a “globally unique identifier” on page 18 and includes an alphanumeric number and a machine scannable QR code.

The Guidance requires your COVID-19 vaccination history to be verified by the digital signatures of authorized persons, like DocuSign. Once you’re up to schedule with your COVID jabs and your papers are in order, you get the PASS, which the Guidance defines as, “A document that gives an individual the authorization to have access to something, such as public spaces, events and modes of transport.” If your globally unique machine scannable QR code checks out, then as long as it does, you will have permission to participate in society.

Although COVID-19 is the WHO’s purported reason that governments need this new vax pass system, the Guidance also makes clear that this system could be used to potentially store a lot more information than your COVID shot history. Here is how the Guidance defines the Health Data which could potentially be a part of this system:

“Health Data: Personal data related to the physical or mental health of a natural person, including the provision of health services, which reveal information about his or her health status. These include personal data derived from the testing or examination of a body part or bodily substance, including from genetic data and biological samples.”

The Guidance also describes how this system could include other Personal Data, including “any information relating to an individual who is or can be identified, directly or indirectly, from that information. Personal data include: biographical data (biodata), such as name, sex, civil status, date and place of birth, country of origin, country of residence, individual registration number, occupation, religion and ethnicity, biometric data, such as a photograph, fingerprint, facial or iris image, health data, as well as any expression of opinion about the individual, such as assessments of his or her health status and/or specific needs.”

Since this definition is broad enough to include your Google search history, you may have the specific need to be hauled off to the state’s inpatient re-education facility! It’s a vax pass today, a social credit score tomorrow.

The Guidance makes no mention at all of the real ethical issues: that it is unethical for governments to have totalitarian control or to build an information system that’s designed to support international totalitarian control. That the system is worse than segregation, because, unlike the evil of segregation, where people deemed second class have a second-class service they can access, it literally shuts out people who don’t want to be vaccinated from the economy, from society, and even blocks their ability to travel to a place that would give them refuge.

So you would be simply a number in a “global system of governance,” through which the Global Governors can control you in every way - and prevent you from escaping the system.

It is mind-boggling to me that Jews would support this - especially Jews who want Israel to be a national refuge.

So much for making Aliyah. If the Global Powers don't want more Jews in the Jewish State, they will prevent us from going.

Their bottom line with this “vaccine” pass is not protecting *you* from Covid. It's protecting *them* from you. The last thing they want, is people asserting their individual and national God-given rights, and challenging their control over you.

Any Jew, any Christian - any person who values their God-given freedom - simply can not let themselves be treated this way

Hope!

Of course, as Rabbi Sacks describes, God *reset* the *reset* attempted by the elites at the time of the Tower of Babel. I have every confidence He will do so this time around, because I am sure His intolerance of tyranny has not abated at all.

But I believe it is up to us to merit that redemption, and assist in every way we can. Although he is not a Jewish Sage, Todd puts it nicely:

The vax pass system cannot work if there is a critical mass of people who come together and decide not to use it -- a critical mass of people, whether vaccinated or unvaccinated, who will not consent. This government derives its power from the consent of those who comply with requirements to use their smart phone passports. If you comply, you're complicit. It may

be tempting to “be normal” or to get the benefits. But if you use it, you enable a system of worldwide segregation. We hope that you see by now why the public should have every reason to distrust this vax pass system, and every reason to distrust the people behind it. Regardless whether you are vaccinated, let us determine to never participate in a system of vaccine passports, or if you have used a vax pass, to delete it and never use it again. As we join the growing movement in Europe, Australia, and Israel, this can become the Civil Rights movement of our time.

The OpenVAERS Project allows browsing and searching of the reports without the need to compose an advanced search (more advanced searches can be done at medalerts.org or vaers.hhs.gov).
