

The evidence is monumental but the Unselect Committee of politically partisan hacks, and someone who had a steaming hot affair with a Chinese spy, hides the facts.







Here's a good summary of what's going on behind the scenes. The bigger picture. This is about the global battle to control our destiny, our bodies and our money. I believe this to be totally true. The Bretton Woods Agreement was negotiated in July 1944 by delegates from 44 countries at the United Nations Monetary and Financial Conference held in Bretton Woods, New Hampshire. Thus, the name "Bretton Woods Agreement."

Under the Bretton Woods System, gold was the basis for the U.S. dollar and other currencies were pegged to the U.S. dollar's value. In February of 1945, FDR arranged to buy oil with Abdul Aziz ibn Saud (Kingdom of Saudi Arabia). The 1945 agreement between the US & Saudi Arabia cemented the relationship between the dollar and oil. **The petrodollar was born.**

OPEC (Currently) has 12 members: Algeria, Angola, Ecuador, Iran, Iraq, Kuwait, Libya, Nigeria, Qatar, Saudi Arabia, United Arab Emirates and Venezuela.



The Bretton Woods System effectively came to an end in the early 1970s when President Nixon announced that the U.S. would no longer exchange gold for U.S. currency.

In 1971, President Richard Nixon took the United States off of the gold standard. As a result, countries could no longer redeem U.S. dollars in their foreign exchange reserves for gold. With this action, Nixon went against the 1944 Bretton Woods Agreement. His move sent the price of gold skyrocketing.

In 1973, Nixon asked Congress for military aid to Israel in the Yom Kippur War. The newly-formed Organization of the Petroleum Exporting Countries (OPEC) halted oil exports to the United States - the OPEC Oil Embargo. Remember oil was traded in the petrodollar, US currency was used as the standard of the world because of our Constitution and laws.

In 1973 - the same year - SWIFT (Society for Worldwide Interbank Financial Telecommunication) was implemented for all countries. The WEF is trying to remove BRICS from SWIFT.

SWIFT has 2 types of transactions:

TPP (Trans-Pacific Partnership)

TTIP (Transatlantic Trade and Investment Partnership)



SUNDANCE: The BRICS economic partnership was formed during the Obama administration. Brazil, Russia, India, China and South Africa (BRICS) saw President Obama sub-contracting, actually giving away, U.S. trade policy to the U.S. Chamber of Commerce (corporations.) In the aftermath of the 2007 economic crisis created by the financial system, the BRICS group was rightly concerned.



In the aftermath of the great housing/financial crisis, the relationships around the World Bank (WB), International Monetary Fund (IMF), EU central banking system and various multinational institutions and, more importantly, multinational corporations, merged even closer with the government. The priorities of the Davos and World Economic Forum (WEF) crowd were now virtually indistinguishable from many national governments.

We are fifteen years downstream from that inflection point, and we are now seeing the outcomes. **The WEF is now giving direct instructions to installed politicians for government policy. Put another way, multinational corporations are now telling government officials what to do.**

Think of “The Great Reset” or “Build Back Better” or climate change, as examples. Worse yet, those governments are doing exactly what the WEF has told them to do.


(1) BRICS was created during Obama term as the trade bloc realized Obama was serious about selling out the U.S. and they needed a foil against corporate driven globalism.

(2) Our economic adversaries realized Obama's intent to kill the U.S., the fundamental change part, would mean massive bleeding into a pool of corporate piranhas'...

(3) BRICS realized the result would be a monster unleashed into the world. Yes, BRICS do not align with the U.S. ideologically (Wall Street driven), but the monster when matured would be too big for them to battle.

(4) The nations who assembled BRICS, saw Obama giving the U.S Commerce Dept to Wall Street via the U.S. Chamber of Commerce.

The US CoC would write the trade deals [TPP (transpacific, and TTIP (transatlantic)] to the benefit of the multinationals.



(5) Obama Inc were cool with that because it was in line with the ideology, the overall plan to weaken the U.S. and get us knocked down. Obama-Inc also knew kickbacks would forever maintain their elite status.

6) But a totally corporate driven transpacific trade pact and a totally corporate driven transatlantic trade pact, meant the multinational corps would have more power and control than the government's involved.

7) This might be okay for Davos and WEF crews, but some nations, specifically some types of leaders, do not like corporations having more power than the government.

Ultimately, BRICS was formed as a counterbalance to this dynamic.

(8) After the 2016 election, the BRICS group essentially dissolved, they didn't even have their annual meetings, because Trump was viewed as breaking the corporate influence. Trump's America First program was a wrench in

the TPP/TTIP machine.

(9) It was the totality of the multinational corporate interests who were impacted by Trump that aligned against Trump, to get rid of Trump, because he was fucking it all up with his economic nationalist agenda.

(10) As soon as Trump was removed, literally within days of the 2020 election, the BRICS group were back on the phone together planning their first meeting in four years on the back of the 2021 G20 summit.

(11) In the BIGGER PICTURE that no one in media is allowed to discuss, you find this economic dynamic. BRICS -vs- WEF/EU/NATO. It's clear as day in the Russia/Ukraine conflict.

(12) India didn't abstain from the Security Council vote because of a lack of sympathy for Ukraine. India abstained because the BRICS relationship is ultimately more consequential to India, and strategically much more important than Ukraine, or NATO, or anything else.

(13) As Putin deals with all facets of this Ukraine issue, harshly or not, you will not see Brazil, India, China or South Africa act, vote, or do anything of substance against him.

The bigger issues are way bigger than Ukraine.

SUNDANCE: As a result, if you really boil it down to the common denominator what you find is the BRICS group are the opposing element to the WEF assembly.

BRICS are not against capitalism in its original form; the BRICS assembly is against corporatism controlling the outcome of government policy. The leaders of Brazil, Russia, India, China and South Africa joined together in order to make sure their subset of economic power put government at the top of the control and power dynamic, and multinational corporations under them. This is their essential commonality.

The leaders within BRICS could see the future of what this process would mean. Everything is about the economics. There are trillions at stake.

Additionally, the Word Economic Forum, the assembly of the multinational corporations in control of economics and trade, would now be dictating policy to NATO, the European Union, Central Banks, International Monetary Fund, World Bank and eventually the World Trade Organization (WTO).

When President Trump was elected, for the first time since their assembly, BRICS saw a U.S. President with a completely different agenda. Donald Trump was not in favor of multinational corporations running and influencing government. Ideologically, as an economic nationalist, Trump was of the same mindset as the BRICS group.

When President Trump took office, he literally tore up the TPP trade agreement that Tom Donohue had established, he kicked the U.S. Chamber of Commerce out of government, and he established his own trade negotiating teams to put government back in charge of trade policy.

President Trump took us out of TPP, withdrew from the Paris Climate Treaty, dropped TTIP, triggered NAFTA renegotiations, initiated tariffs against our economic adversaries (multinationals) and told NATO to start preparing to take care of themselves. Trump was the first economic nationalist president in modern history.

Commerce Secretary Wilbur Ross, U.S. Trade Representative Robert Lighthizer, Treasury Secretary Steven Mnuchin and White House Trade and Economic Advisor Peter Navarro took over from the U.S. Chamber of Commerce. Trump established the economic and trade goals, the team worked the granular details, and ultimately Trump made the decisions, yes or no.

After Trump took this approach, the BRICS group essentially dissolved.

With the United States now confronting the WEF, NATO, the EU and all the multinationals (often called globalists), the BRICS team could pause their mission.

Factually, BRICS didn't even meet during Trump's term, because the U.S. trade and economic policy known as 'America First', was essentially in alignment with the BRICS mission.

Unfortunately, it was the scale of the WEF, EU, NATO and multinational opposition to President Trump that eventually won. All the multinational corporations, including Big Tech and ideological globalists in media, aligned to remove President Trump. That was the scale of the opposition.

In the aftermath of the 2020 election, literally just days after the election, the BRICS group was back on the phone planning to start meetings again in 2021 on the sidelines of the G20 summit. The BRICS group are back together because the multinationals are back in control.

For obvious reasons, part of the BRICS agenda is to create a trade currency that is not the dollar. With the recent sanctions put into place against Russia, we can see why that was always going to be important.

In many very direct ways, what we are seeing in this Russia -vs- Ukraine crisis is a geopolitical battle between the outlook of BRICS (economic nationalists) and the NATO, EU, World Economic Forum, multinational corporate assembly, i.e. economic globalists.

At stake in the Ukraine battle is the modern structure of the global economy and international politics. This is why we see Joe Biden along with NATO, the EU and all of the affiliates under the control of the World Economic Forum going so hard against Russia.

The TPP removes legislative authority from Congress and the White House on a range of issues. Judicial power is often surrendered to three-person trade tribunals in which ONLY corporations are permitted to sue. Workers, environmental and advocacy groups and labor unions are blocked from seeking redress in the proposed tribunals. The rights of corporations become sacrosanct. The rights of citizens are abolished. The people lose ALL THEIR HUMAN RIGHTS.

Not only that, but TPP and TiSa quickly would enable corporations to achieve monopoly, privatized power over our healthcare, media, food, water, energy, and money, all part of the TPP/TiSa plan to control EVERY industry we require for survival.

4. Developed Strong Relationships with Middle Eastern Nations Based on Mutual Interests
5. Was Ruthless with the Taliban While Winding Down the Afghanistan War
6. Crushed the ISIS Caliphate
7. Demonstrated a Consistent Willingness to Take out the Bad Guys
8. Stood Up to China
9. Strategically Used Unpredictability as an Asset in Foreign Affairs
10. Advanced Tough Russia Policies and Provided Lethal Aid to Ukraine while Maintaining an Open Dialogue

Each of these points are worthy of unpacking in-depth, but there are several that illustrate the dramatic difference in approach between Trump and Biden, starting with Afghanistan.

When President Trump initiated the process of ending America's longest war, senior officials huddled in the Situation Room to discuss tactical challenges on the ground. The president reminded the group of America's humiliating withdrawal from Saigon at the end of the Vietnam War, and said we must do whatever it takes to leave in a safe, orderly, and dignified way.

When military leaders bemoaned the costs and logistical challenges of bringing home our equipment, the president said that he did not care if it was a helicopter or a styrofoam cooler. If it had an American flag on it, it was either coming home or getting destroyed to keep it from falling into the hands of our enemies. He vowed that we would leave on our terms, or we would not leave at all.

Tragically, President Biden's approach – which included the decision to abandon the strategically important Bagram Air Base prior to the evacuation – cost the lives of 13 American servicemembers and led to the Taliban parading victoriously through Kabul with billions of dollars of American combat equipment.

The administration's stunning incompetence – detailed in an official U.S. Army report – made the United States look weak and vulnerable on the world stage, and Putin was watching.

The world took notice when Trump ordered the killing of Iranian terrorist general Qassem Soleimani, who had operated with impunity throughout the Middle East until the U.S. military sent two Hellfire missiles through his vehicle.

As a candidate for president, Biden released a statement condemning the righteous attack as a “hugely escalatory move” that brought us to “the brink of a major conflict across the Middle East.” This, of course, proved to not be the case, but it illustrated Biden’s unwillingness to do what it takes to establish credible deterrence.

This principle of deterrence applies across the globe, which explains why the Chinese military has sent a record number of airplanes into Taiwan’s air defense identification zone since Biden took office.

To the specific case at hand, Trump was much tougher on Russia than the media have led people to believe, while Biden has been far softer.

Trump deployed such aggressive sanctions against Russia that President Obama’s Secretary of Defense Robert Gates called them the toughest in history, and he withdrew from one-sided treaties that hamstrung the U.S. while Russia violated the terms.

Biden has taken the opposite approach, appeasing Putin by handing him his top two geopolitical priorities on a silver platter. He unconditionally extended the New Strategic Arms Reduction Treaty, allowing Russia to continue building tactical nuclear weapons while constraining our ability to modernize. And while Trump imposed sanctions to stop Russia’s Nord Stream 2 pipeline in its tracks, construction was allowed to resume when Biden took office.

President Trump understood the power of building American energy dominance. By slashing onerous regulations, Trump sparked an American energy boom that ensured we would never be reliant on any other nation to meet our energy needs. Geopolitically, America’s increased export capacity reduced Putin’s leverage over our European allies, who depend on Russia for 40 percent of their gas and more than a quarter of their oil.

Trump approved the Keystone XL oil pipeline at home and shut down Russia’s Nord Stream 2 gas pipeline in Eastern Europe. Biden reversed both decisions, meaning he has been harder on America’s energy producers than he has been on Russia’s. To add insult to injury, as the Russian army pushed into Ukraine, Biden’s climate envoy John Kerry hoped aloud that “President Putin will help us to stay on track with respect to what we need to do for the climate.”

Vladimir Putin’s appetite for expansion did not wane during the four years Trump was in office, and the world was not just miraculously a safer place. Bad actors like Putin simply knew that they had to restrain themselves or deal with the consequences.

In nearly every way possible, President Biden has weakened the United States and our allies and empowered Putin. As a result, Russia is on the march, even as the Ukrainian people have inspired the world with their courage and resilience. And in the wings, America’s greatest threat – Xi Jinping’s China – waits, and watches.”




