COVID-19 vaccine injuries are real and certainly not rare. There are tens of millions of people in America who have been injured by the COVID vaccines. 3. Doing a biopsy on your brain or nerves. This is definitive, but few people are going to want to have a brain biopsy just to prove to their doctors that they are sick.
