

## The technologies used for gene modification include;

A) CRISPR - CRISPR (Clustered Regularly Interspaced Short Palindromic Repeats) is a gene editing technology that allows scientists to make precise changes to an organism's DNA. CRISPR works by using a protein called Cas9, which acts like a pair of molecular scissors to cut DNA at a specific location. The Cas9 protein is guided to the target location by a small RNA molecule that is designed to match the DNA sequence at the desired site of modification. Once the DNA is cut, the cell's natural repair mechanisms can be harnessed to either delete, replace, or insert new genetic material at the site of the cut. CRISPR has numerous applications in fields such as medicine, agriculture, and environmental science, and is being hailed as one of the most significant scientific breakthroughs of the 21st century.

B) MFP1 is a protein that can be modified by a type of enzyme called casein kinase II when it is studied outside of its normal biological context, which is called "in vitro." It is also a protein that is typically found in the nucleus of cells, where it appears to be involved in organizing the structure of the nucleus.

Specifically, MFP1 is able to bind to a type of DNA called MAR DNA, which is involved in regulating the activity of genes. MFP1's location in the nuclear matrix, which is a supportive structure in the nucleus, suggests that it helps to connect the MAR DNA to other components of the nucleus, such as the nuclear envelope. This could be important for regulating gene expression and maintaining the integrity of the nucleus.

C) Gene drives use genetic engineering to introduce a modified version of a gene that is more likely to be passed on to the next generation than would occur by chance. For example, a gene drive might be designed to ensure that a particular gene is always passed on to all of an organism's offspring, rather than the usual 50% chance.

Gene drives have been proposed as a potential method for sterilizing or reducing the population of certain organisms, particularly those that are considered pests or disease vectors. Here are a few examples:

Mosquitoes: Gene drives have been developed to target genes involved in mosquito reproduction, with the goal of reducing the population of disease-carrying mosquitoes that spread malaria, dengue fever, and other diseases. One approach involves introducing a modified gene that produces a protein toxic to mosquito offspring, which can then spread rapidly through the population, eventually causing a decline in the mosquito population.

## PFIZER PREGNANCY DATA

Some freshly released Pfizer documents regarding the pregnancy of vaccinated mothers. It was known from the cases reviewed of the Pfizer safety database as of 28 February 2021, that out of 248 jabbed 51 had spontaneous abortions! Reports were submitted voluntarily, and the magnitude of under reporting is unknown.

**Defense Advanced Research Projects Agency (DARPA)** is heavily involved in gene research, including gene editing technologies like CRISPR-Cas9, as well as research on infectious diseases and biodefense. In 2013, DARPA awarded Moderna a \$25 million grant to support the

development of mRNA-based vaccines and therapies for infectious diseases. As part of Operation Warp Speed, the US government entered into a contract with Moderna in July 2020 to provide funding of up to \$1.525 billion for the development, testing, and manufacture of Moderna's COVID-19 vaccine.

Prior to this Moderna had not sold a single commercial product and all the animals that were injected with mRNA died prematurely but the golden goose was the opportunity to use this gene therapy, to cure diseases and in the ultimate search for eternal life, and what better sample to test it on than a willing population fearful of death from a contagion.



### Brain Death is a Lie




